

SigniFlow V2025.1.3.0 Release notes. 01st April 2025





New Features/Enhancements (SigniFlow)

- Added additional cleanup processes to clean empty directories in the temp directories.
- Made changes to the GetCreateWorkflowLink API response to ensure that once a user logs in that they are redirected back to the document's workflow setup.
- Added Workflow tags support to the FullWorkflow API call. This will allow users to upload documents with auto tagging enabled and contains Workflow tags.
- Improved signature image cropping.
- Improved data sorting and filtering speed on Completed basket.
- Improved sliding animation between workflow setup steps for smoother UX.
- Improved performance on document prepper when scanning for auto tagging on a document.
- Added DKIM support for emails sending from the system on hybrid servers.
- Changes made for local signing integration SDK to allow fetching of custom certificates.
- Added a Content-Security-Policy and Permission Policy.
- Additional messages added to the "Bulk Signing" page.
- Reduced the number of emails being sent for a group workflow step by not sending "Action Taken" emails to each signer, if the number of signers in the group is the same number of required signers.
- Removed unnecessary 'Apply to all pages' prompt when stamping or initialling single-page documents..
- Added an additional server and business setting to customise the number of characters being masked for mobile numbers on the OTP confirmation screens.
- Added .dot document support on document upload.
- Added password ban list on reset password page. (The password reset page link is sent out when a user forgets their password.)
- Added a configuration setting to allow users to capture additional data during workflow creation. The additional data captured can be sent along on events to a configured event handler.
- Made security enhancements on DocPrepper to ensure only relevant user data is returned to the browser for the current user session.
- Changed the document rejection process to redirect the user to different page where other pending documents can be actioned.
- Performance changes made for document auto tagging scanning.
- Added a workflow time frame report.
- Removed unused pages from system admin section.
- Added the ability to add custom validation scripts to DocPrepper fields when calling the following API methods:
 - o DocPrepperAddFields
 - o DocPrepperAddFieldsFlowID
 - o AddFaceToFaceSignerFields
 - o DocPrepperAddFieldsFlowIDValue
 - o DocPrepperAddFieldsFlowIDValueWithFonts
 - o AddFaceToFaceSignerFieldsValue
 - o FullWorkflow



- Added a GetValidationScripts API method to fetch all configured Field Validation Scripts.
- Added localised dates to the portfolio audit page.
- Added a business security rule that when switched on, forces the email copy of a document to go to a specific email address in addition to the other email addresses added.
- Added a single use token for the URL response from the GetDocumentPrepperLink API call.
- Added the ability to certify document and portfolio audit logs upon download.
- Improved the Azure AD integration to check the user's department in Azure AD and assign the user to the same department in SigniFlow if it exists.
- Improvements made to signature image generation quality.
- Added FieldName property to the response dataset for the DocPrepperGetAllFields API.
- Added a security rule to disable forms company wide.
- Added additional security validation in the background when adding users to a workflow.
- Enabled unlicensed users (SignFree) within a company to log in via Azure AD on hybrid servers.
- Removed the file path listing on the portfolio cover page when downloading a portfolio.
- Ensure change language links are encrypted.
- Updated the change language process to validate that only available languages can be set when passing an encrypted language selection.
- Made the dropdowns searchable on the system admin departments page.
- Added the ability to set a user's designation on their profile when nothing has been set, when filling in a designation field during the signing process.
- Added the ability to provide a time zone to use when doing any of the Signing Ceremony API calls.
- Added a "Send From Number" for Twillio SMS integration.
- Added a "Date Completed" column on the completed basket page.
- Added the ability for approvers to Initial All.
- Removed fields that are no longer required from the business creation system admin page.
- Added the ability to apply a field "comb" on API for fillable text fields on FullWorkflow API.
- Added the LawTrust certificate option to use certificate modal in EasiSign.
- Added the SigniFlow default option to use certificate modal in EasiSign.
- Updated the layout and design of the "Use Certificate" modal in EasiSign.
- Added additional cleanup to avoid script injection through custom messages.
- Changed the forgot password page process to follow OWASP standards more closely in terms of feedback provided to the user.
- Changed the styling for the approve and reject buttons when in mobile view.
- Reduced text size on the instruction modal for mobile view in EasiSign.
- Reduced heading size on the instruction modal for mobile view in EasiSign.
- Reduced image size on the instruction modal for mobile view in EasiSign.
- Added the ability to extract database connection credentials from Azure Key vault for the application's configuration file.
- Ensured the contact support link/button is added to all critical errors.
- Added DocFusion configuration page to allow for system events to be sent through to a dedicated DocFusion event listener.
- Changed the Document Management Interface (DMI) application to REST API.
- Implemented debounce on all the baskets on the dashboard to delay data being pulled from the server while searching and filtering on the relevant grids.
 - Updated the design of the reject document modal for clearer feedback and improved usability.
- Added configuration options to allow overriding the "MailFrom" email address when sending emails on hybrid servers.



- Made changes to the SMS account setup to allow saving the account information without a business name and telephone number.
- Changed legacy pop-ups to new modern pop-ups.
- Updated some icons on the document prepper page.
- Implemented background application registration to enable email services to scale across multiple servers without sending duplicate emails.
- Ensured that the Reset Password page can apply custom branding files on hybrid servers.
- Added GlobalSign QSS integration.
- Changed audit PDF generation from webkit to blink for better alignment and more stable conversion.
- Added the ability to set an auto delegation on your profile for when you are out of office, to allow the designated user to sign on your behalf.
- Changed HTML to PDF conversion for HTML files being uploaded.
- Changed excel sheet generation for report backing data.
- Added the ability to configure a default proxy value for all documents.
- Removed PA functionality from business admin user page.
- Added the "Undesignated Signers" feature, enabling users to include unnamed signers in workflows and designate them during the signing stage.

Fixes/Bug Fixes (SigniFlow)

- Fixed an issue where the signing reason for USB tokens is missing a space between the signer's name and "Signed By".
- Fixed an issue where the "Signing Completed" page does not redirect to an external redirect URL when provided.
- Fixed an issue where certain special characters in a user's email would prevent them from logging in.
- Fixed an issue on the business admin section where the link to the notification page was incorrect.
- Fixed an issue on DocPrepper where fields placed after each other were not aligned correctly.
- Fixes an issue on the Twillio SMS integration where the initial setup will fail in some cases.
- Standardised syntax, grammar, and casing across UI labels and messages.
- Fixed missing translations.
- Fixed an issue where the toggle for "Basic Signatures" did not apply the setting correctly.
- Fixed an issue where document storage would not connect on certain UNC paths.
- Fixed an issue where a user is not able to update their mobile number if they do not have a national ID number set.
- Fixed an issue where EasiSign configuration is not saving due to signature border settings being incorrect.
- Resolved a translation issue causing the "Signing Complete" page to fail rendering because of missing Unicode character encodings.
- Fixed progress bar on EasiSign for approver workflows.
- Unstacked some of the models that appear on EasiSign when opening a document. Models have been set to trigger after each other instead of appearing all at once.
- Fixed an issue where the delete and edit portfolio template buttons weren't showing.
- Disabled the Sign All button on EasiSign when using USB token signing to avoid signing errors due to token issues.
- Fixed an issue on EasiSign registration where the proceed button becomes hidden below the footer depending on the user's screen size.
- Fixed an issue where the "Stamp All" button would remain visible after apply the stamp to all pages during the signing process.



- Fixed an issue where the Edit Workflow page would not load content in some scenarios.
- Fixed an issue where a user without a mobile number would be kicked to the login screen when attempting to create workflows.
- Fixed issue with refreshing data when department details are updated in the system admin department page.
- Fixed an issue where teams and departments are not being populated on the Share Portfolio options inside DocPrepper.
- Fixed an issue on the Circulating page where Cancel all and Remind all would not always action all of the documents as required.
- Fixed an issue where Initial All would fail if a user's full name contained 2 spaces next to each other.
- Fixed an issue where a user is not able to create portfolio templates in certain scenarios.
- Fixed an issue during initial all where the user is not able to use the QR code option to draw on a mobile device
- Fixed an issue where electronic signature images are not generated correctly in some scenarios.
- Fixed an issue where pending portfolio shares are not actioned correctly for group workflow signers.
- Fixed an issue where you can create a predefined face to face workflow step without adding face to face signers.
- Fixed an issue in EasiSign where the user's signature appearance can get updated with incorrect values in certain scenarios.
- Removed empty tooltips on EasiSign menu buttons.
- Removed company contacts functionality in its current state.
- Fixed column filtering on grids in all dashboard baskets.
- Ensured that the disable delete and download rules are applied correctly on the relevant dashboard grids based on the owner of the document.
- Fixed issues on TeamDocs where the open button is not always available in some scenarios.
- Fixed an issue where new users are not able to workflow documents from a portfolio that another user has added to the portfolio.
- Fixed an issue on signature validation in EasiSign where it shows invalid signatures in some scenarios but when downloading the PDF, they signatures are valid.
- Fixed an issue, where editing the workflow of a document in a portfolio does not provide the same level of access to the new signer which causes the new signer to not be able to open the document.
- Fixed an issue where the audit log does not always open correctly when opening the audit log from EasiSign.
- Fixed an issue where the user gets redirected away from the document once they have finished signing even though they must approve as the next step as well.
- Fixed an issue on PDF documents where field placement is done incorrectly due to negative origin values on the PDF content itself.
- Fixed an issue where invalid characters can be used for group names which can cause script injection.
- Fixed an issue where the "Hide Personal Information" rule is not being applied to electronic signatures.
- Fixed an issue where the combined audit and document attachment is not always generated correctly.
- Fixed an issue where the red X is not visible on fields during document prepper if a field is placed on the right-hand side border of the document, or on the top border of the document.
- Fixed an issue where users were not able to change their language in the business admin section.
- Fixed an issue where a font signature gets used when the EasiSign configuration is set to User choice and the user uploads or draws their signature.
- Fixed an issue where document names that contain Unicode characters are named incorrectly when attached to emails.
- Fix a positioning issue on circulating grid where the grid buttons are not aligned in some scenarios.



- Fixed an issue in reporting where non-English dates get sorted incorrectly.
- Fixed incorrect tooltip wording on business settings page.
- Fixed apply all initials and Initial all functionality to ensure the border is applied on the custom initials.
- Fixed Ad-Hoc F2F signing where a document could be signed by both the ad-hoc f2f signer and witness without applying the ad-hoc initial fields.
- Fixed language selector issue in EasiSign to ensure the whole button item is clickable and not only certain parts of it.
- Removed redundant tooltips on EasiSign top menu.
- Fixed an issue where bulk sign fails in certain scenarios.
- Fixed an issue where Azure AD login can fail in certain scenarios on EasiSign.
- Fixed an issue where negative values can be provided for the Auto Expiry options in business settings.
- Fixed an issue where 3D Liveness signing fails in some instances.
- Fixed an issue on Edit workflow page where documents that contain viewers are not editable.

New Features/Enhancements (KYC)

- Added Shareholding percentage on FICA Business Declaration.
- Added email addresses on the FICA Business Declaration.
- Added additional sanction products to KYC.
- Added new text and styling for the KYC QR code popup.
- Updated KYC to .NET 8.

Fixes/Bug Fixes (KYC)

- Fixed an issue on KYC address matching where addresses formatted in a certain way does not return a matched address from Google.
- Fixed an issue on the KYC process where an incorrect font was being used during data capturing.
- Fixed an issue where the KYC button is incorrectly shown and hidden when logging in via AzureAD and other oAuth and SAML authentication methods.
- Fixed an issue where multiple OTPs could be sent on KYC initialisation when a user refreshes the page multiple times.
